Nifty Technical Outlook: -

On Friday, Nifty has opened on a flat note but has unable to sustain the marginal opening gains and it corrected and it closed at 10452 with 93 points down. Technically, the short term trend has turned weak on chart till it sustains and trades below 10666-mark. The medium to long term trend remains upward until and unless it gives closing below 9960-10030 marks. Nifty, till it trades below an important support level of 10666 the weakness is likely to be continue in coming days and is an every rise may witness for profit booking opportunity on chart. The correction was also due on chart since long. On downside it has support at 10330-10220. The fresh Bull Run is likely to resume only if it trades and sustains above 10888 only.

For the day, it may trade positive only if it trades above 10488. it may move towards 10522-10555. If it slides below 10422 then the weakness is likely to continue today also. In this case, it may find the next support at 10388-10366-10333.

Nifty F&O Highlights:-

Nifty Jan 10600 and 10500 Call strikes have seen the maximum addition of 17.9 and 16.8 lacs shares in Open Interest.

Nifty 10400 and 10300 Put strikes have seen the maximum addition of 3.9 and 1.7 lacs shares in open Interest.

Nifty 10600 Call strike has the maximum Open interest more than 53.5 lacs shares in open Interest followed by 11100 strike stood at more than 51.1 lacs shares among all Call strikes.

Nifty 10500 Put strike has the maximum Open Interest more than 58.3 lacs shares followed by 10000 strike stood at more than 46.3 lacs shares.

FIIs have added the long position in Index Future on Friday. They have added 1342 in Index Future long while they have added the positions in Index Future short by 2445. On option side, they have reduced the 316 Open Interests in Index PUT short where they have added 775170 in Index PUT long. On Call side, they have added 5187 in Index CALL short and added 10346 in Index CALL long. Overall, they have added the 11372 positions in long against short added by 13804.

Today News / Corporate Action

Punjab National Bank: The Reserve Bank of India (RBI) said it has not asked Punjab National Bank to pay counterparty banks against the letters of undertaking that the lender issued to jeweller Nirav Modi and others. RBI said it has begun its assessment and will take action as needed.

UCO Bank, Allahabad Bank: State-owned UCO Bank on Saturday said it has exposure of \$411.82 million (about Rs 2,636 crore) in the Rs 11,400-crore PNBBSE -2.98 % fraud committed by billionaire jeweller Nirav Modi and his associates. Allahabad Bank has reported an exposure of around Rs 2,000 crore.

Fortis Healthcare: The Delhi Debts Recovery Tribunal (DRT) has restrained former CEO of Ranbaxy Laboratories and the co-owner of Fortis Healthcare, Malvinder Mohan Singh, from selling a posh property in Lutyen's Delhi and some other assets in a bank loan default case.

IOC: Indian Oil Corp will invest Rs 70,000 crore to raise its oil refining capacity by about a quarter by 2030 as it takes the lead to meet rising energy needs of the country. IOC will expand its refining capacity to 116.55 million tonnes per annum (MTPA) by 2030 from the current 80.7 MTPA with an investment of about Rs 70,000 crore

Tata Steel, Bhushan Steel: Tata Steel has emerged as a frontrunner to acquire debt-laden Bhushan Power and Steel after lenders to the company decided that they would only consider Tata Steel's offer of Rs 24,500 crore for further negotiations on Wednesday, setting aside an offer by rival steel-maker JSW Steel that is lower by Rs 11,500 crore.

Reliance Industries: Billionaire industrialist Mukesh Ambani on Sunday said his firm Reliance Industries (RIL) and its global partners will set up the country's first integrated digital area in Maharashtra, entailing investments of Rs 60,000 crore.

City Union Bank: About \$2 million was stolen from City Union Bank accounts last week after a cyberattack compromised the SWIFT messaging system with payment instructions being sent to other banks in multiple jurisdictions. The bank detected the transactions while reconciling accounts and about half the money has been retrieved.
