# Nifty Technical Outlook: -

On Tuesday, Nifty has opened flat and it has been range bound throughout the day and it closed flat 10360 with 18 points down. Technically, the short term trend has turned weak on chart till it sustains and trades below 10666-mark. The medium to long term trend remains upward until and unless it gives closing below 9960-10030 marks. Nifty, till it trades below an important support level of 10666 the weakness is likely to be continue in coming days and is an every rise may witness for profit booking opportunity on chart. The correction was also due on chart since long. On downside it has support at 10330-10220. The fresh Bull Run is likely to resume only if it trades and sustains above 10888 only.

For the day, it trades positive only if it trades above 10388 then it may move towards 10422-10444. If it slides below 10333 then the weakness is likely to continue today also. In this case, it may find the next support at 10299-10266-10222.

# Nifty F&O Highlights:-

Nifty Jan 10400 and 10350 Call strikes have seen the maximum addition of 4.9 and 3.3 lacs shares in Open Interest.

Nifty 10300 and 10400 Put strikes have seen the maximum addition of 16.3 and 10.5 lacs shares in open Interest.

Nifty 11100 Call strike has the maximum Open interest more than 48.4 lacs shares in open Interest followed by 10400 strike stood at more than 46.5 lacs shares among all Call strikes.

Nifty 10300 Put strike has the maximum Open Interest more than 62.0 lacs shares followed by 10000 strike stood at more than 50.7 lacs shares.

FIIs have added the long position in Index Future on Tuesday. They have added 3225 in Index Future long while they have added the positions in Index Future short by 24354. On option side, they have added the 6578 Open Interests in Index PUT short where they have added 829979 in Index PUT long. On Call side, they have added 11509 in Index CALL short and added 5464 in Index CALL long. Overall, they have added the 15267 positions in long against short added by 31733.

#### **Today News / Corporate Action**

Eros International: In a move that will add heft to Jio's content strategy, Mukesh Ambani's Reliance Industries is acquiring 5 per cent stake in NYSE-listed Eros International, holding company of Indian movie company Eros International Media (Eros India). As part of the deal, an overseas subsidiary of RIL will acquire Eros' shares for \$15 a piece, at an 18 per cent premium to the last closing price.

SpiceJet: India's air passenger growth has become the highest in the world, validating ace investor Rakesh Jhunjhunwala's interest in the aviation sector. Jhunjhunwala, who has bought shares of all three listed airline entities in the country, bought another 10 lakh shares of SpiceJet last week. The investor first bought shares of SpiceJet in 2012 and did a bulk purchase in November 2014, when the airline was on a downward trajectory that led to it shutting operations for a day in December.

Aurobindo Pharma: Aurobindo Pharma has expressed early stage interest in the European business of the \$1.7 billion privately-held Canadian drug maker Apotex. Known for its high-profile litigations in the US against multinational pharma companies.

Tata Steel: Tata Steel, India's oldest producer of the alloy, plans to raise up to \$800-900 million through overseas borrowings to replace expensive debt and to raise cash for buying stressed local mills.

Ambuja Cements: The board of Ambuja Cement has approved a Rs 1,400-crore clinker plant at Rajasthan, with the LafargeHolcim unit seeking to enhance its presence in the northern and western markets that together consume more cement than any other part of India. The plant, which would come up at Marwar Mundwa by the second half of 2020, will eventually have a capacity of 3.1 million tonnes.

HDFC: HDFC managing director Renu Sud Karnad on Tuesday said the company is open to both organic and inorganic growth. Replying to a media report that HDFC was in discussion to acquire health insurance company Apollo Munich, Karnad said, "Partners of Apollo Munich and the partners of ours are the same and there is nothing as yet."
