#### Nifty Technical Outlook: -

On Friday, Nifty has opened gap up by around 40 points in opening trade & continues its uptrend throughout the session and finally closed at 10491.05. Technically, the short term trend has turned weak and is likely to remain weak on chart till it sustains and trades below 10666-mark. The medium to long term trend remains upward until and unless it gives closing below 9960-10030 marks. As of now, an every rise may witness for profit booking and may face resistance near resistance level. The correction was also due on chart since long. On downside it has support at 10475-10440. The fresh Bull Run is likely to resume only if it trades and sustains above 10888 only.

For the day, it trades positive only if it trades above 10560 then it may move towards 10620-10660. If it slides below 10475 then the weakness is likely to continue today also. In this case, it may find the next support at 10440-10386-10360.

### Nifty F&O Highlights:-

Nifty Mar 10500 and 10900 Call strikes have seen the maximum addition of 8.3 and 7.5 lacs shares in Open Interest.

Nifty 10300 and 10400 Put strikes have seen the maximum addition of 10.1 and 9.1 lacs shares in open Interest.

Nifty 10700 Call strike has the maximum Open interest more than 30.3 lacs shares in open Interest followed by 10500 strike stood at more than 28.7 lacs shares among all Call strikes.

Nifty 10000 Put strike has the maximum Open Interest more than 35.7 lacs shares followed by 10400 strike stood at more than 30.8 lacs shares.

JSW Steel: Private steel maker JSW Steel is close to acquire Italy-based Aferpi, a steel firm, for Rs 600 crore, a source in the know of the matter said.

Dr Reddy's Labs: Pharma major Dr Reddy's today said it has received the establishment inspection report (EIR) from the US Food and Drug Administration for its its formulations facility in Srikakulam, Andhra Pradesh.

Tata Steel: Tata Steel is seeking UK government backing for a £60-million project at its Port Talbot steelworks in Wales, according to a media report on Sunday.

Arvind: UBS has initiated coverage on Arvind with a 'buy' rating with a target price of Rs 515. The company has a better retail strategy than its competitors, which the market has not yet identified, said UBS. UBS said potential value creation from the company's recently announced plan for a demerger is not priced in.

Videocon: The lenders of bankrupt Videocon Industries have appointed consulting firm KPMG as resolution professional, replacing Alvarez & Marsal, two senior bank executives said. The decision to appoint KMPG was taken after the lenders decided to invite fresh bids for the post of resolution professional after other contenders questioned the process followed in appointing Alvarez & Marsal a month ago

Mahindra & Mahindra: Mahindra & Mahindra, India's biggest farm equipment maker, is forming a joint venture with XL Catlin to enter the Rs.1.3 lakh crore general insurance market in the country.

Reliance Industries: Mukesh Ambani's Reliance Industries (RIL) will invest over □55,000 crore in electronics oil & gas sectors in Andhra Pradesh, it said on Sunday, the second day of CII Partnership Summit in Visakhapatnam.

Idea Cellular: Closure of Vodafone and Idea's mobile tower sale deal, and raising FDI limit in the Aditya Birla group firm are holding the government's approval to the merger of two operators to create the largest Indian telecom player
