Nifty Technical Outlook: -

On Monday, Nifty has seen the positive opening taking positive clues from global markets and extended the gains during the day Finally it closed at 10582 with 92 points positive. Technically, the short term trend is likely to remain weak on chart till it sustains and trades below 10666-mark. But it takes support near 10300 and bounced back. The medium to long term trend remains upward until and unless it gives closing below 9960-10030 marks. As of now, an every rise may witness for profit booking till it trades below 10660. The correction was also due on chart since long. On downside it has support at 10330-10220. The fresh Bull Run is likely to resume only if it trades and sustains above 10888 only.

For the day, it trades positive only if it trades above 10611 then it may move towards 10633-10666. If it slides below 10555 then it may find the next support at 10522-10488.

Nifty F&O Highlights:-

Nifty Mar 10900 and 11000 Call strikes have seen the maximum addition of 4.3 and 3.0 lacs shares in Open Interest.

Nifty 10500 and 10600 Put strikes have seen the maximum addition of 8.2 and 7.0 lacs shares in open Interest.

Nifty 10700 Call strike has the maximum Open interest more than 30.4 lacs shares in open Interest followed by 11000 strike stood at more than 30.2 lacs shares among all Call strikes.

Nifty 10000 Put strike has the maximum Open Interest more than 34.0 lacs shares followed by 10400 strike stood at more than 32.2 lacs shares.

FIIs have added the long position in Index Future on Monday. They have added 12843 in Index Future long while they have added the positions in Index Future short by 291. On option side, they have added the 5899 Open Interests in Index PUT short where they have added 449167 in Index PUT long. On Call side, they have added 1167 in Index CALL short and added 5312 in Index CALL long. Overall, they have added the 24054 positions in long against short added by 18382.

Today News / Corporate Action

Ambuja Cements, ACC: The long-due merger between the LafargeHolcim's Indian operations, Ambuja Cements and ACC, was called off on Monday due to some "current constraints". The transfer of mines between the two was proving to be uneconomical.

PNB: The state-run lender told exchanges late on Monday that the quantum of unauthorised transactions using SWIFT could rise by \$204.25 million, or Rs 1,322 crore. The bank had on February 14 disclosed that unauthorised transactions worth \$1.8 billion, or Rs 11,300 crore, had been carried out from its Brady House branch. With this, the total amount lost to fraud now stands at about Rs 12,622 crore.

Hindustan Unilever: The Directorate General of Safeguards (DGS) has sought clarifications from Hindustan Unilever on the methodology used to arrive at Rs 119 crore that the company offered to the government after it could not pass the entire benefits of GST.

Reliance Infrastructure: The company has won an arbitration award of Rs 292 crore against the government of Goa in a case relating to non-payment of dues for electricity supplied by the former

OBC: Oriental Bank of Commerce (OBC) on Monday said that the alleged fraud of Rs 389.85 crore by Dwarka Das International will not impact its profitability as the lender has made full provisions for the defaulted amount in its books

Reliance Industries: An official panel has approved \$4-billion investment plans by Reliance Industries and BP to develop three sets of natural gas discoveries in the KG Basin

Monnet Ispat: The first of the 12 big nonperforming loans referred by the Reserve Bank of India for resolution under the Insolvency and Bankruptcy Code (IBC) last year has reached closure with the committee of creditors approving the offer made by a consortium of Aion Capital and JSW Steel for Monnet Ispat. JSW will keep Monnet as a separate legal entity but they will ultimately be merged
