Nifty Technical Outlook: -

On Wednesday, Nifty has seen the gap down opening more than 80 points and has been trading whole day with negative biased. It closed at 10493 with 62 points negative. Technically, the short term trend is likely to remain weak on chart till it sustains and trades below 10666-mark. But it takes support near 10300 and bounced back. The medium to long term trend remains upward until and unless it gives closing below 9960-10030 marks. As of now, an every rise may witness for profit booking till it trades below 10660. The correction was also due on chart since long. On downside it has support at 10330-10220. The fresh Bull Run is likely to resume only if it trades and sustains above 10888 only.

For the day, it trades positive only if it trades above 10522 then it may move towards 10555-10588. If it slides below 10533 then it may find the next support at 10444-10422.

Nifty F&O Highlights:-

Nifty Mar 10550 and 10750 Call strikes have seen the maximum addition of 1.5 and 0.1 lacs shares in Open Interest.

Nifty 10350 and 9200 Put strikes have seen the maximum addition of 1.4 and 0.2 lacs shares in open Interest.

Nifty 11200 Call strike has the maximum Open interest more than 12.5 lacs shares in open Interest followed by 11300 strike stood at more than 8.5 lacs shares among all Call strikes.

Nifty 10600 Put strike has the maximum Open Interest more than 20.1 lacs shares followed by 11500 strike stood at more than 10.1 lacs shares.

FIIs have reduced the long position in Index Future on Wednesday. They have reduced 2997 in Index Future long while they have added the positions in Index Future short by 1668. On option side, they have added the 6019 Open Interests in Index PUT short where they have added 474919 in Index PUT long. On Call side, they have reduced 831 in Index CALL short and added 7584 in Index CALL long. Overall, they have added the 10606 positions in long against short added by 13121.

Today News / Corporate Action

HDFC: Housing Development Finance Corporation Ltd, India's biggest mortgage financier, launched a Rs 1,896-crore share sale to institutional investors to expand its bailiwick to health insurance and other businesses and to buy more shares in the group's banking entity.

Idea Cellular: Idea Cellular will launch its Voice over LTE (VoLTE) services for employees, in select markets starting from March 1. The Kumar Mangalam Birla owned telecom operator on Wednesday said VoLTE services will be launched in over 30 cities across 4 circles in the first half of the month.

Canara Bank: State-owned Canara Bank has filed a fresh complaint against Kolkata-based computer maker RP Infosystem and its directors with the Central Bureau of Investigation (CBI) for their involvement in loan fraud running into about Rs 850 crore.

Fortis Healthcare: Promoter holding in the troubled healthcare company Fortis has decreased to an all-time low of 0.77 per cent from just 3 per cent a week ago and 34.40 per cent at the end of December 2017.

PG Electroplast: The company has commissioned the UF Toilet Seat manufacturing facility. This UF toilet seat facility is one of its kind in India and the technology and knowhow for the facility has been imported by PG ElectroplastB

V-Mart Retail: The retailerhas opened two fashion stores one in the state of Uttar Pradesh and one in the state of Bihar. With this the tally of stores in Uttar Pradesh in 54 fashion stores and 17 composite stores and in Bihar is 31 fashion stores and 5 composite stores

Cadila Healthcare: The company has received the final approval from USFDA to market Dexmedetomidine Hydrochloride Injection 200 mcg (base)/2 mL (100 mcg (base)/ mL single-dose vials. The drug is indicated for sedation of intuated and mechanically ventilated patients during treatment in an intensive care setting and for sedation of non-intubated patients prior to and /or during surgical and other procedures. Corporation Bank: The bank said it had declared the accounts of Ramnandi Estates Pvt Ltd as a non-performing asset (NPA) in September 2016 and has categorised it as fraud account.
