#### Nifty Technical Outlook: -

On Monday, Nifty has witnessed for gap down on a weak global cues. It has extended the losses during the day and it closed at 10358 with 100 points down. Technically, the short term trend is likely to remain weak on chart till it sustains and trades below 10666-mark. Last week, it has failed to cross above it. On downside it has an immediate support at 10300. It is likely to weak more once it slipped and closed below 10300. In this case, it may have the next support at 10000. The medium to long term trend remains upward until and unless it gives closing below 9960-10030 marks. The fresh Bull Run is likely to resume only if it trades and sustains above 10660 only.

For the day, it trades positive only if it trades above 10399 then it may move towards 10422-10444. If it slides below 10333 then it may find the next support at 10300-10266.

#### Nifty F&O Highlights:-

Nifty Mar 10450 and 10350 Call strikes have seen the maximum addition of 1.6 and 1.6 lacs shares in Open Interest.

Nifty 10250 and 9300 Put strikes have seen the maximum addition of 1.0 and 0.2 lacs shares in open Interest.

Nifty 11200 Call strike has the maximum Open interest more than 11.8 lacs shares in open Interest followed by 11300 strike stood at more than 8.3 lacs shares among all Call strikes.

Nifty 10600 Put strike has the maximum Open Interest more than 14.4 lacs shares followed by 11500 strike stood at more than 10.1 lacs shares.

FIIs have reduced the long position in Index Future on Monday. They have reduced 5488 in Index Future long while they have added the positions in Index Future short by 13183. On option side, they have reduced the 669 Open Interests in Index PUT short where they have added 513958 in Index PUT long. On Call side, they have added 8873 in Index CALL short and added 12721 in Index CALL long. Overall, they have added the 6564 positions in long against short added by 35507.

#### **Today News / Corporate Action**

Reliance Communications: An arbitration court has "restrained" Reliance Communications (RCom) from selling or transferring assets without its permission, and set June 9 as the date for the next hearing, dealing a blow to the Anil Ambaniowned telco's efforts to pare debt by March end under a plan driven by its lenders.

Reliance Infra: Anil Ambani-led Reliance Infrastructure has slapped a Rs 5,440.38-crore arbitration notice on the former promoters of Pipavav Defence & Offshore Engineering citing breaches of warranties and representations by them at the time of acquisition. The amount claimed by Reliance Infrastructure is more than double of the Rs 2,000 crore it paid for acquisition of Pipavav Defence & Offshore Engineering in 2015.

Tata Motors: JLR UK has reported total sales of 2,238 units in February, comapred with 2,647 units in the same quarter last year.

IndusInd Bank, Jaypee Infratech: IndusInd Bank has invoked 6 crore pledged shares, which make up about 4.32 per cent stake, of the crisis-hit Jaypee Infratech. These shares were held by Jaypee Infratech's promoter Jaiprakash AssociatesBSE -2.29 %, which is the flagship company of debt-ridden Jaypee group. The group is facing protest from home buyers for significant delays in completing of housing projects in Noida.

SBI: The lender's Hong Kong branch does not have any exposure against any corporates/banks based upon LOUs/LCs issued by PNB, Brady House Branch, SBI Hong Kong said. Further, SBI Hong Kong Branch does not have any exposure to the Nirav Modi Group of companies and / or Mehul Choksi group of companies whose names are linked to the PNB fraud

ONGC: Energy majors ONGC Videsh -- a subsidiary of ONGC, and Oil India besides other participating firms on Monday received approval from the government of Mozambique for the development plan of Golfinho-Atum natural gas field in the southern African nation. The Golfinho-Atum natural gas field is located in the Area-1 block of Rovuma offshore basin of Mozambique.
