#### Nifty Technical Outlook: -

On Monday, Nifty has witnessed for the gap up opening and continues its uptrend throughout the session, finally ended at 10421.40 up by 194.55 points or 1.90%. Technically, the short term trend is likely to remain weak on chart till it sustains and trades below 10666-mark. Last week, it has failed to cross above it and it made a low of 10141 and bounced back. The biasness may turn on positive side once it trades and sustains above 10450. The medium to long term trend is likely to remains upward until and unless it gives closing below 9960-10030 marks. The fresh Bull Run is likely to resume only if it trades and sustains above 10660 only.

For the day, if it trades positive only if it trades above 10450 then it may move towards 10600-10666, where it is likely to face hurdle to cross it. If it slides below 10201 then it may find the next support at 10188-10144.

#### Nifty F&O Highlights:-

Nifty Mar 10600 and 11500 Call strikes have seen the maximum addition of 15.0 and 2.1 lacs shares in Open Interest.

Nifty 10300 and 10400 Put strikes have seen the maximum addition of 19.1 and 14.3 lacs shares in open Interest.

Nifty 10600 Call strike has the maximum Open interest more than 51.8 lacs shares in open Interest followed by 10500 strike stood at more than 49.6 lacs shares among all Call strikes.

Nifty 10000 Put strike has the maximum Open Interest more than 54.0 lacs shares followed by 10200 strike stood at more than 45.7 lacs shares.

FIIs have added the long position in Index Future on Monday. They have added 21413 in Index Future long while they have reduced the positions in Index Future short by 9551. On option side, they have added the 12323 Open Interests in Index PUT short where they have added 579504 in Index PUT long. On Call side, they have reduced 826 in Index CALL short and added 13701 in Index CALL long. Overall, they have added the 47437 positions in long against short reduced by 13939.

#### **Today News / Corporate Action**

Infosys: The IT major plans to voluntarily delist its American Depositary Shares from Euronext Paris and Euronext London exchanges, as the low average daily trading volume was not commensurate with the related administrative requirements.

NBCC: State-owned construction firm said that no charges have been established against its CMD Anoop Kumar Mittal as allegations against him were not corroborated during the CBI investigation

Videcon Industries: Financially distressed Videocon Group may give up India rights for two global brands — Philips in the TV business and Electrolux in appliances — after being unable to sustain production without working capital, which has caused a steep decline in sales

Bata India: Sebi has directed Bata on Monday to conduct an inquiry into the leak of price-sensitive financial information. The regulator has asked the company to take action against those responsible for the leak and strengthen its internal processes.

Bharti Airtel: The company has approved a plan to raise about Rs 16,500 crore through debt, including a fresh issue of \$1 billion in overseas bonds, to help refinance loans and pay for spectrum, boosting the telco's shares by almost 5 per cent.

ACC, Ambuja Cements: Having put their merger on hold, ACC Ltd and Ambuja Cements — the two Indian units of LafargeHolcim — on Monday said they plan to enter into a 'master supply agreement' with each other. The agreement is for supply of cement, clinker and raw materials such as fuels, fly ash, slag and gypsum. This would also include spare parts.

Mahindra & Mahindra: Automobile major Mahindra & Mahindra has bought two floors in its own corporate headquarters Mahindra Towers in Mumbai's Worli locality from a group company of Gautam Singhania's Raymond Group.

Eicher Motors: Eicher Polaris, an equal joint venture between homegrown Eicher Motors and US-based Polaris Industries for personal utility vehicle space, has decided to shut down its operations with immediate effect.
