#### Nifty Technical Outlook: -

On Tuesday, Nifty has witnessed for the gap up opening at 10188.00 and ended at 10184.15 up by 0.53 percent or 53.50 after the government lower-than-expected announced borrowing programme for the first half of the fiscal year 2019. Technically, the short term trend is likely to remain weak on chart till it sustains and trades below 10330-mark. The biasness may turn on positive side once it trades and sustains above 10330. The medium to long term trend is likely to remains upward until and unless it gives closing below 9960-10030 marks. The fresh Bull Run is likely to resume only if it trades and sustains above 10660 only.

For the day, if it trades positive only if it trades above 10150 then it may move towards 10200-10220 for the day, where it is likely to face hurdle to cross it. If it slides below 9980 then it may find the next support at 9920-9900. Overall, the biasness remain weak on chart until and unless it trades above 10220-10330.

### Nifty F&O Highlights:-

Nifty Mar 10250 and 10350 Call strikes have seen the maximum addition of 8.3 and 1.6 lacs shares in Open Interest.

Nifty 10150 and 9100 Put strikes have seen the maximum addition of 9.5 and 0.2 lacs shares in open Interest.

Nifty 10250 Call strike has the maximum Open interest more than 20.2 lacs shares in open Interest followed by 10350 strike stood at more than 7.5 lacs shares among all Call strikes.

Nifty 10150 Put strike has the maximum Open Interest more than 13.2 lacs shares followed by 9400 strike stood at more than 8.7lacs shares.

FIIs have added the long position in Index Future on Tuesday. They have added 5723 in Index Future long while they have added the positions in Index Future short by 3292. On option side, they have reduced the 6403 Open Interests in Index PUT short where they have added 804407 in Index PUT long. On Call side, they have added 7219 in Index CALL short and reduced 3962 in Index CALL long. Overall, they have reduced the 4642 positions in long against short added by 16890.

#### **Today News / Corporate Action**

Fortis Healthcare: Fortis Healthcare's hospital division will be hived off and merged with Manipal Hospitals apart from which it will sell a majority stake in its SRL Diagnostics unit to the same group. The transaction will lead to the listing of Manipal Hospitals as the largest hospital services provider in the country by revenue.

IDBI Bank: State-owned IDBI Bank on Tuesday said the CBI has registered cases in the two of the five complaints with regard to loans aggregating to Rs 772 crore for pisciculture. It said in a regulatory filing, the bank had sanctioned pisciculture loans during the period from FY2009 to FY2013 at a few branches of erstwhile state of Andhra Pradesh.

MEP Infra: MEP Infrastructure Developers (MEP) on Tuesday said it has won projects worth Rs 2,921.83 crore in Maharashtra through a joint venture (JV) with Long Jian Road & Bridge Company. The company now has a total of 9 projects on hybrid annuity mode (HAM) valued at Rs 6,758.77 crore.

RIL: Reliance IndustriesBSE -0.12 % has sold part of the assets owned by its US-subsidiary Reliance Eagleford Upstream to Sundance Energy for \$110 million, the Mukesh Ambaniled company said Tuesday. "Reliance Industries continues to retain its interest in the remaining Eagle Ford assets that are core to its development priorities. The sale is expected to close in 1QFY19 and is subject to customary closing conditions,"

Tata Motors: Jaguar Land Rover and Waymo have inked a long-term strategic partnership to develop the world's first premium selfdriving electric vehicle, reports ET. The vehicle will be used for Waymo's driverless transportation service. Jaguar Land Rover and Waymo (formerly Google self-driving car project) will work together to design and engineer self-driving Jaguar I-PACE vehicles.

SBI: State Bank of India has hiked 2-10 year retail term deposit rates by 10-25 bps, ETNOW reported on Wednesday quoting agencies.

MCX: The Central Bureau of Investigation (CBI) has alleged that officials of the erstwhile Forward Markets Commission colluded with Jignesh Shah, former MD of MCX, and the commodity exchange's then
