## Nifty Technical Outlook: -

Indian equity markets have reacted positively after RBI bi-monetary policy and it closed at its resistance level of 10330 on Friday. Technically it has huddle above 10330 and may witness for profit booking before trading above it. The short term trend is likely to remain weak on chart till it sustains and trades below 10330-mark. The biasness may turn on positive side once it trades and sustains above 10330 only.

The profit booking is likely to accelerate once it got re-breached the 10200 on down side. In this case it may find the next support at 9960-10030. Once it breaches all the aforesaid support levels then it may find the next support at 9660. Which is more likely to visible in coming days? Overall the biasness remains weak on chart and trend is SELL ON RISE till it trades below 10330 on closing basis. For the day, the trend is positive only if it trades above 10355 then it may move towards 10388-10411. If it slides below 10301 then it may find the next support at 10277-10244-10222.

# Nifty F&O Highlights:-

Nifty Apr 10500 and 10450 Call strikes have seen the maximum addition of 3.6 and 1.8 lacs shares in Open Interest.

Nifty 10300 and 10000 Put strikes have seen the maximum addition of 7.1 and 4.2 lacs shares in open Interest.

Nifty 10500 Call strike has the maximum Open interest more than 40.1 lacs shares in open Interest followed by 11000 strike stood at more than 38.1 lacs shares among all Call strikes.

Nifty 10000 Put strike has the maximum Open Interest more than 52.8 lacs shares followed by 10200 strike stood at more than 36.2 lacs shares.

FIIs have reduced the long position in Index Future on Friday. They have reduced 23777 in Index Future long while they have reduced the positions in Index Future short by 138766. On option side, they have added the 205898 Open Interests in Index PUT short where they have reduced 13315 in Index PUT long. On Call side, they have added 194832 in Index CALL short and added 95043 in Index CALL long. Overall, they have added the 277164 positions in long against short added by 277164.

#### **Today News / Corporate Action**

Binani Industries: Binani Industries has decided to move the Supreme Court with an appeal to redeem the pledge of its assets in debt-ridden subsidiary Binani Cements from its lenders and will also submit 10 per cent of the offer to prove its commitment. Redeeming the pledge will mean seeking an end to the bankruptcy proceedings against it from the National Company Law Tribunal (NCLT).

HDFC: The country's largest mortgage lender Housing Development FinanceCorp. (HDFC) is in advanced talks to acquire Apollo Munich Health Insurance Co. for an approximate valuation of Rs 1,000 crore, said an ET report. Apollo Munich is a joint venture between Chennai-based Apollo Hospitals promoted by Prathap C Reddy and his family and Munich Re.

Tata Chemicals: Tata Chemicals on Sunday said it has signed a pact with Allied Silica Limited to acquire its precipitated silica business for Rs123 crore on a slump sale basis. The deal is expected to be closed within three months, the company said in a release. The acquisition is a part of the Rs 295 crore investment approved by the board in February last year, towards this specialty business.

Titan: Titan Company on Friday released its pre-quarterly update for Q4FY18. The release mentioned that its jewelry segment saw mid-teen retail sales growth during the quarter. The division is benefitted immensely from the expansion of its gold-exchange program, which has, along with weddings, contributed significantly to new customer addition. Division also saw average ticketsize expansion.

Lemon Tree Hotels: Hospitality chain Lemon Tree Hotels is slated to list its shares on the bourses today. The company's Rs 1,038.68 crore initial public offer (IPO), which was open for subscription from March 26-March 28, was subscribed 1.19 times.

Wipro: India's third largest software services firm Wipro on Friday sold 63 per cent of its stake in Wipro Airport IT to Antariksh Softtech in a Rs 3.15 crore deal. Wipro Airport IT Services is a joint venture (JV) between Wipro (74 per cent) and Delhi International Airport Ltd or DIAL that held 26 per cent stake. It provides various IT services at the Indira Gandhi International
