Nifty Technical Outlook: -

Nifty has been consolidating throughout the day with positive biasness and it closed at 10403 with 23 point up. It has given 2 closing above the immediate resistance level of 10330, which is a positive sign. Technically it had huddle above 10330 for bulls. Now, it has been sustaining and trading above it. Now what next? Technically, it seems on chart that it may move towards next level of 10440-10660, where it may face resistance above it in short term. The fresh bullrun start is likely to once it trades above 10660 only. Till it trades below it has risk and probability to witness for profit booking in near term.

The profit booking is likely to accelerate once it got re-breached the 10300 on down side. In this case it may find the next support at 10220-10030-9960-9660. For the day, the trend is positive only if it trades above 10422 then it may move towards 10444-10488. If it slides below 10388 then it may find the next support at 10366-10333-10300.

Nifty F&O Highlights:-

Nifty Apr 10500 and 10800 Call strikes have seen the maximum addition of 3.5 and 2.2 lacs shares in Open Interest.

Nifty 10400 and 10300 Put strikes have seen the maximum addition of 10.2 and 6.4 lacs shares in open Interest.

Nifty 10500 Call strike has the maximum Open interest more than 43.1 lacs shares in open Interest followed by 11000 strike stood at more than 38.8 lacs shares among all Call strikes.

Nifty 10000 Put strike has the maximum Open Interest more than 46.3 lacs shares followed by 10200 strike stood at more than 39.3 lacs shares.

FIIs have added the long position in Index Future on Tuesday. They have added 6309 in Index Future long while they have reduced the positions in Index Future short by 8086. On option side, they have added the 5405 Open Interests in Index PUT short where they have added 6758 in Index PUT long. On Call side, they have reduced 9651 in Index CALL short and added 4613 in Index CALL long. Overall, they have added the 16327 positions in long against short added by 27306.

Today News / Corporate Action

Fortis Healthcare: PG Capital-backed Manipal Hospitals has decided to sweeten the terms of its offer to acquire the hospitals and the SRL Diagnostics unit of Fortis HealthcareNSE 3.39 % after institutional and minority shareholders such as Rakesh Jhunjhunwala expressed their disappointment with the plan. Ranjan Pai-led Manipal and TPG have decided to rework the earlier swap ratios in response to complaints that Fortis had been undervalued.

Mahanagar Gas: BG Asia Pacific Holdings Pte (now owned by Royal Dutch Shell Plc), is looking to sell up to 7.5 per cent stake, worth \$ 103 million (nearly Rs 670.50 crore), in Mahanagar Gas though a block trade on Wednesday

Blue Star: Air-conditioner maker Blue Star has called off plans to set up a manufacturing unit in Samba, Jammu due to non-availability of fiscal incentives.

Star Cement: Star Cement along with its subsidiaries have received Rs. 80.26 crore towards Subsidies claim from the Central Government and this amount shall be utilized towards pre-payment of loans.

Jubilant Life Sciences : Macquarie has reiterated its outperform rating on Jubilant Life Sciences with a target price of Rs 1,096 citing improved free-cash generation. As specialty's contribution increases over the medium term, the brokerage expects overall EBITDA margins and freecash generation to scale up.

CDSL: Sebi has rejected a proposal by the Central Depository Services Ltd board to extend the tenure of its CEO PS Reddy by five years. The capital market regulator has only approved a oneyear extension for Reddy until March 2019

Reliance Infra: A division bench of the Delhi High Court has directed Delhi Metro Rail Corporation (DMRC) to take over servicing of all debt liabilities of Reliance Infrastructure subsidiary Delhi Airport Metro Express, the Anil Ambani-led company said on Tuesday.

Jet Airways: The aviation company said it won't participate in the call for bids for national carrier Air India. "We welcome the government move to privatise Air India. It is a bold step," said Amit Agarwal, CFO at Jet AirwaysNSE -1.75 %. "However, considering the terms of offer in the information memorandum and based on our review, we are not participating in the process," he added. Jet was rumoured to be interested in Air India.
