Nifty Technical Outlook: -

Nifty has opened on a flat to positive note taking cues from global markets. Finally it closed at 10614 with 30 points positive. Technically, it has been holding above an important support level of 10330 from last couple of days, which is a positive sign for bulls. It seems on chart that it may move towards next level of 10660, where it may face resistance above it. The fresh bull-run start is likely to once it trades above 10660 only. Till it trades below it has risk and probability to witness for profit booking in aforesaid resistance level. The profit booking is likely to accelerate once it got re-breached the 10330 on down side. In this case it may find the next support at 10220-10030-9960-9660.

For the day, the trend is positive only if it trades above 10633 then it may move towards 10666-10699. If it slides below 10588 then biasness may turns on profit booking side as small correction waiting on chart then it may find the next support at 10555-10522.

Nifty F&O Highlights:-

Nifty Apr 10750 and 10650 Call strikes have seen the maximum addition of 1.5 and 0.3 lacs shares in Open Interest.

Nifty 10600 and 10650 Put strikes have seen the maximum addition of 6.8 and 2.2 lacs shares in open Interest.

Nifty 10700 Call strike has the maximum Open interest more than 45.0 lacs shares in open Interest followed by 11000 strike stood at more than 31.0 lacs shares among all Call strikes.

Nifty 10500 Put strike has the maximum Open Interest more than 49.6 lacs shares followed by 10400 strike stood at more than 40.4 lacs shares.

FIIs have reduced the long position in Index Future on Tuesday. They have reduced 6294 in Index Future long while they have reduced the positions in Index Future short by 10458. On option side, they have reduced the 17348 Open Interests in Index PUT short where they have added 6391 in Index PUT long. On Call side, they have reduced 10603 in Index CALL short and reduced 5045 in Index CALL long. Overall, they have reduced the 28687 positions in long against short reduced by 14017.

Today News / Corporate Action

Fortis Healthcare: Malaysian healthcare group IHH and KKR-backed Radiant Life Care have submitted binding offers for Fortis HealthcareNSE 0.96 % on Tuesday to compete with Manipal-TPG and a joint offer from Hero Enterprise Investment-Burman Family Office. IHH has submitted a binding offer to infuse Rs 650 crore immediately into Fortis Healthcare, while Radiant-KKR have submitted a binding offer to purchase Fortis Mulund for Rs 1,200 crore without any due diligence.

Bharti Airtel: The telecom major's India operations reported their first net loss in almost 15 years in the fourth quarter of 2017-18 and joined Idea Cellular and Vodafone India in the red, as Reliance Jio-led low tariffs and a cut in international termination rates (ITR) took toll on the country's largest telco. The company eked out a net profit of Rs 83 crore on a consolidated basis — also its lowest in nearly one-and-a-half decades — in the just-ended quarter, a 78 per cent year.

Wipro: Leading IT exporter Wipro is slated to declare its March quarter results today. All eyes are firmly on the management commentary on its energy segment that accounts for nearly 13 per cent of the software major's revenues. Besides, an update on healthcare vertical will be keenly tracked. HDFC Securities Institutional Research believes that the IT firm would lag peers in terms of FY19-20 growth.

IDFC Bank: Private player IDFC Bank today reported over 76% plunge in standalone net profit to Rs 41.93 crore for the March quarter on rise in bad loans and higher provisioning. The bank had registered a net profit of Rs 175.95 crore in the January-March quarter of the previous fiscal, 2016-17. Its total income was however higher during the fourth quarter of 2017-18 at Rs 2,374.35 crore as against Rs 2,279.65 crore in the year-ago period, the bank said in a regulatory filing.

ICICI Bank: ICICI Bank has abandoned plans to sell its non-banking finance company that was primarily into home finance after more than two years of trying and is now looking to expand its loan book through the affordable housing segment that saw a spike in demand due to government subsidy. ICICI Home Finance (IHF) will also restart financing consumer durables purchases 10 years after stopping that business in the bank.
