Nifty Technical Outlook: -

On Thursday, Nifty has witness for high volatile during the day and it closed at 10680 with 38 points down. Today was 2nd consecutive profit booking day after making recent high of 10784. Technically, till Nifty holds above 1066610633 it is a positive sign for bulls. Now, the short term trend is likely to remains positive on chart. In this case it has potential to move towards 10888-11222 in coming days. The above positive view is likely to be negated if it unable to holds above 10666 and it slips further below 10330-mark. As of now it has good support at 10330. Nifty till trades and holding above 10330 the biasness may stay on positive side and it may have buy on dips opportunity on market.

For the day, the trend is positive only if it trades above 10722 then it may move towards 10755-10777. If it slides below 10655 then it may find the next support at 10633-10611-10588.

Nifty F&O Highlights:-

Nifty May 10000 and 10500 Call strikes have seen the maximum addition of 0.8 and 0.7 lacs shares in Open Interest.

Nifty 10300 and 10000 Put strikes have seen the maximum addition of 4.0 and 2.9 lacs shares in open Interest.

Nifty 11000 Call strike has the maximum Open interest more than 59.7 lacs shares in open Interest followed by 10800 strike stood at more than 37.9 lacs shares among all Call strikes.

Nifty 10500 Put strike has the maximum Open Interest more than 45.0 lacs shares followed by 10600 strike stood at more than 34.5 lacs shares.

FIIs have added the long position in Index Future on Thursday. They have added 5374 in Index Future long while they have reduced the positions in Index Future short by 1338. On option side, they have reduced the 5308 Open Interests in Index PUT short where they have added 2253 in Index PUT long. On Call side, they have reduced 2009 in Index CALL short and reduced 5902 in Index CALL long. Overall, they have reduced the 5836 positions in long against short reduced by 1094.

Today News / Corporate Action

Bharti Airtel: The telecom major plans to raise as much as \$1.5 billion by diluting about a fourth of its stake when it lists the holding company for Africa operations, Bharti AirtelNSE -0.99 % International (Netherlands) BV (BAIN BV), in early 2019, said people with knowledge of the matter. The money will help bolster the telco's efforts to stay competitive in the Indian market, where Bharti has just declared its first quarterly loss in contrast with profits in Africa.

Tata Motors: As part of its effort to reduce debt and monetise non-core assets, Tata MotorsNSE -0.76 % on Thursday sold its defence and aerospace portfolio to Tata Advanced Systems (TASL) to unlock their full potential. The move is likely to bring in proceeds in excess of Rs 700 crore on the Tata Motors books, subject to regulatory and other approvals

PC Jeweller: Funds managed by Fidelity International halved their holdings in PC Jeweller this week, shedding more than twothirds of their original stake in the New Delhi-based company that lost about 60 per cent of its market value in seven trading sessions until Wednesday. Direct and indirect subsidiaries of Fidelity and funds managed by the global asset manager sold another 3.53 per cent (1.39 crore shares) on the stock market on Monday, cutting their stake to 3.51 per cent (1.38 crore shares), Fidelity informed Mumbai stock exchanges on Thursday.

JSW Energy: JSW Energy reported a net loss of Rs 483 crore in the fourth quarter of 2017-18 as against a net profit of Rs 24 crore a year ago, as the provisions made for loans given to Jaiprakash Power VenturesNSE 1.37 % ate into the company's profits. Total income in the quarter was Rs 1,879 crore as against Rs 1,935 crore in the corresponding quarter of the previous year.

Finolex Cables: The tussle between the Chhabria cousins, belonging to the founder families of the Finolex group, has taken a murky turn — with the bitter feud throwing up a tricky question of corporate law: Can the board of a company sit in judgement on one of its independent directors? And caught in the family battle over the Rs 10,000 crore business empire is Crawford Bayley & Co one of the country's oldest law firms and a senior partner.
